The Seller agrees to transfer ownership of the following horse:

The Seller (Giant Steps Therapeutic Equestrian Center) agrees to transfer ownership of the horse ("Buddy") to the Buyer (Collins Equestrian) for the purchase price of \$0

Upon Transfer of Ownership of the Horse, the Buyer (Collins Equestrian) assumes all care, risk of loss, or injury to the horse.

If the Buyer (Collins Equestrian) cannot take care of the horse ("Buddy"), the Buyer will notify the seller for right of first refusal for ownership of the horse. If the horse ("Buddy") is sold or ownership is transferred, the Buyer (Collins Equestrian) will notify the seller (Giant Steps Therapeutic Equestrian Center) with the name, address, telephone number and email address of the new owner to which the horse will be transferred so that the seller (Giant Steps Therapeutic Equestrian Center) may know the whereabouts of the horse ("Buddy")

The undersigned agrees that this animal will only be transferred privately and will not be resold at any type of auction, to a known horse broker, feed lot or slaughter destination. In the event the undersigned fails to comply with the terms of this Transfer of Ownership the seller (Giant Steps Therapeutic Equestrian Center) reserves the right to commence legal proceedings to recover the horse.

The Seller ("Giant Steps Therapeutic Equestrian Center") makes no warranties whether expressed or implied, including but not limited to, any implied warranty of merchantability or fitness for a particular purpose. The purchase of the horse ("Buddy") is subject to the terms and conditions of an "as is" sale. It is further noted that the Seller (Giant Steps Therapeutic Equestrian Center) is the sole owner of horse ("Buddy") and has authority to enter into this Transfer of Ownership. There is no lien or encumbrance on the horse ("Buddy"). Upon Seller's receipt of the purchase price, in full, seller (Giant Steps Therapeutic Equestrian Center) shall provide buyer (Collins Equestrian) with horse's ("Buddy") registration papers, if any, and all other documents necessary to transfer registration of the horse from the seller (Giant Steps Therapeutic Equestrian Center) to the buyer (Collins Equestrian)
