Windridge Therapeutic Equestrian Center of East Texas, Inc. is a non-profit that equine-assisted services to children, adults, and veterans with physical disabilities, mental health and/or emotional needs.

Adoption shall not be interpreted as ownership of equine. Adoption, for the purpose of this contract, is to assume care of the equine with the contingencies set forth in this document.

The parties listed in this agreement agree to the following:

ADOPTION AGREEMENT:

- 1. This agreement shall remain in effect from the effective date listed on document, until the equine is no longer at the Adopter's facility or at the time of equine's death.
- 2. Adopter acknowledges that continued possession of said horse is contingent upon Adopter fulfilling all obligations, terms, and conditions pursuant to the signed Agreement for said equine, and any breach of the Agreement requires the immediate return of said equine to Windridge Therapeutic Equestrian Center of East Texas, Inc.
- 3. Adopter understands and agrees that equines adopted per this Agreement are intended to be cared for and placed with the Adopter for the remainder of the equine's natural lives.
 - **a.** Should an adopter decide they are unable to care for the equine, the equine must be returned to Windridge Therapeutic Equestrian Center of East Texas, Inc. free of charge.
- 4. Adopted equine will never be sold, transferred, released, or placed in the possession of anyone that will cause or allow the equine to be sold at auction for slaughter.
- 5. The equine above is never under any circumstances to be adopted, auctioned, released, or given away.
- 6. Equines adopted from Windridge shall never be bred, beaten, or abused. Adopter shall always treat equines with kindness. Adopter shall provide a copy of this Agreement to any boarding stable or veterinarian Adopter uses.
- 7. Adopter acknowledges an opportunity to inspect the equine, including the use of a qualified veterinarian, has been offered and/or conducted and is satisfied with the equine's condition.
- 8. Both parties are aware of equine's current health and care needs, equine is adopted "as is" and "with all faults." Adopter is agreeing to assume care of equine listed in document.
- 9. Upon the effective date listed on this Agreement, Adopter is agreeing to provide all necessary veterinary and farrier care. Windridge is not responsible for the vet care, farrier care, board, or feed costs of the equine listed in this document until such a time as a horse is returned back to our facility per the conditions laid out in this contract.

- 10. Adopter shall only euthanize a Windridge equine for sound medical reasons. In the event that the Adopter must euthanize, Adopter shall notify Windridge immediately, when possible. In all cases, Adopter shall notify Windridge within twenty-four (24) hours of euthanasia and provide proof of humane euthanasia from the Adopter's veterinarian.
- 11. While Adopter has possession of equine listed in this document, the Adopter shall, with notice, allow Windridge to schedule a visit to where equine is housed.
- 12. Windridge will provide copies of equine's history. Adopter acknowledges that all Windridge equine are donated to Windridge Therapeutic Equestrian Center of East Texas, Inc and Windridge may have limited to no knowledge of the equine's history prior to it coming to Windridge Therapeutic Equestrian Center of East Texas, Inc. Prior to intake all horses are evaluated by staff and a veterinarian, copies of documentation of vet visits, floating records, and training while at Windridge may be available for Adopter.
