SANCTUARY FOR ABUSED AND NEGLECTED EQUINES: THE FOUNDATION PROVIDES RESCUE AND SANCTUARY TO ABUSED, NEGLECTED AND ABANDONED HORSES WHO HAVE NO OTHER ALTERNATIVE FOR LIFE. TO HELP FUND OUR SANCTUARY OPERATIONS AND THE CARE OF OUR APPROXIMATELY 60 EQUINES, WE HAVE "FRIENDS OF EQUAMORE". DONORS MAY BECOME "FRIENDS OF EQUAMORE" BY PARTICIPATING IN OUR "BUY-A-BALE PROGRAM" AND THROUGH OUR HORSE SPONSORSHIP PROGRAM. FOR OUR BUY-A-BALE PROGRAM, DONORS PLEDGE A MONTHLY RECURRING DONATION OF AT LEAST \$20 (THE AVERAGE COST OF A BALE OF HAY). ADDITIONALLY, ONE OR MORE DONOR MAY CHOOSE TO SPONSOR A PARTICULAR HORSE BY DONATING ALL OR A PORTION OF THE COST OF CARING FOR A SPECIFIC HORSE THEY SELECT. THOSE DONORS ALSO OFTEN ESTABLISH A RELATIONSHIP WITH THE HORSE THEY SPONSOR, BENEFITING BOTH THE DONOR AND THE HORSE. OUR YEAR ROUND BUY-A-BALE

OREGON HAY BANK: THE OREGON HAY BANK PROVIDES ASSISTANCE TO RESPONSIBLE HORSE OWNERS FACING FINANCIAL CRISIS WITH HAY AND FEED ASSISTANCE, HOOF CARE AND VETERINARY SERVICES SO THEY CAN KEEP THEIR HORSES AT HOME. WE HAVE A HIGH SUCCESS RATE WITH THIS PROGRAM IN THAT OVER 90% OF HORSES HELPED REMAIN IN THEIR HOMES - AND DO NOT NEED TO BECOME EQUAMORE HORSES. QUALIFYING ORGANIZATIONS MAY ALSO REQUEST ASSISTANCE WITH UP-FRONT COSTS OF RESCUING UNWANTED HORSES AND ASSISTANCE DURING TIMES OF CRISIS SUCH AS NATURAL DISASTERS.

EDUCATION: WE ARE DETERMINED TO EDUCATE THE PUBLIC NOT ONLY ABOUT OUR SANCTUARY AND OUR HORSES, BUT ABOUT THE SIGNIFICANT PROBLEM OF UNWANTED HORSES AND HORSE ABUSE AND NEGLECT NATIONALLY. WE INCLUDE THIS INFORMATION IN NEWSLETTERS, EVENTS, PRESENTATIONS, SANCTUARY TOURS, AND OUR WEB SITE. OUR LONG TERM GOAL IS TO HAVE OUR RESCUE AND SANCTUARY WORK BECOME UNNECESSARY.
