### 2. Background:

This horse was originally donated to Good Hope by the Rehoming Recipient and has since served in therapeutic/equestrian programming. The horse has now retired from active work and is being returned to the previous owner for lifetime care and retirement.

### 3. Terms of Rehoming:

The Rehoming Recipient agrees to the following:

#### a. Lifetime Care Commitment

The Recipient agrees to provide the horse with humane care, proper shelter, appropriate feed and clean water, routine veterinary care, dental care, farrier service, and parasite control throughout the remainder of the horse's natural life.

#### **b. No Sale or Transfer Clause**

The Recipient shall not sell, lease, auction, or transfer ownership of the horse to any third party. If at any time the Recipient is unable or unwilling to continue caring for the horse, **the horse must be returned to Good Hope.**

#### **c. Veterinary Oversight**

The Recipient agrees to notify Good Hope of any serious illness, injury, or death of the horse. Euthanasia, unless in the case of a medical emergency, must be based on veterinary recommendation and communicated to Good Hope.

#### **d. Facility Standards & Pre-Approval**

The horse will reside at the following location:

As part of the rehoming process, **Good Hope will consult with the Recipient's boarding facility, veterinarian, and farrier** to confirm that appropriate care standards will be met. Good Hope reserves the right to request photos or visit the property prior to transfer.

#### **e. Right of Inspection**

Good Hope retains the right to conduct welfare checks, either in person or through a designated representative, with reasonable notice, to ensure the horse's well-being.

#### **f. Liability Release**

Upon transfer, the Recipient accepts all responsibility and liability for the horse. Good Hope shall not be liable for any injury, damage, or loss caused by the horse after the date of transfer.
