EQUINE ASSISTED SERVICES INCLUDE PHYSICAL THERAPY, OCCUPATIONAL THERAPY, SPEECH THERAPY, ADAPTIVE RIDING INCLUDING MOUNTED AND UNMOUNTED HORSEMANSHIP.
