President's Letter

The EQUUS Foundation was born from love of equestrian sport and the critical need to provide care to horses after their sport careers are over. We awarded our first grants in 2003 to seven equine charities based in Connecticut and the metropolitan New York area and now support hundreds of charities nationwide.

While there has been significant progress in reducing the number of America's horses destined for slaughter, there are still over 20,000 shipped across our borders for slaughter each year and tens of thousands are still subjected to abuse and neglect.

We believe that the best way to help these horses is to transition them into a new life, role and purpose by providing viable options to owners when they cannot, or no longer wish to, care for them before they end up in the slaughter pipeline. I am proud to report that thanks to our Equine Ambassador - Lafitte De Muze - and his owner, Cheryl Olsten, and his rider, Amanda Steege, we were able to establish Lafitte De Muze Safety Net Grants aimed at helping to keep horses with their owners, assisting with re-homing the horses, and providing counseling and end-of-life services when needed.

Looking to the future and in recognition of the labor shortage affecting industry nationwide, we established Equine Studies Scholarships to inspire and reward the next generation of equine professionals. We announced the award of \$13,000 in scholarships to ten undergraduate and graduate level students enrolled in equine studies and veterinary programs at institutions of higher learning listed on the EQUUS Foundation's Equine Education Network.

To raise public awareness that America's horses enhance our lives and need our protection and to build consensus within the equine industry to embrace solutions for equines in transition other than shipping them across our borders for slaughter, we established the #HorseProtector campaign and ended the year with over 1,000 people taking the pledge.

We also released a study by Dr. Karin Bump commissioned by the EQUUS Foundation to examine the sustainability, equine welfare and business-related performance indicators of the equine charities that attained the EQUUS Foundation Guardian designation in 2022. There is every indication that equine charities are making a difference in the lives of horses and the people who benefit from them, but his study reinforces the critical need not just on donations of money, but also donations of products and services, including volunteer labor, from horse lovers who care about where horses go next.

The EQUUS Foundation also established the Spirit Award in 2023 in recognition of its roots in the equestrian sport and to honor equestrians that have significantly elevated the image and desirability of horses. In accepting the inaugural Spirit Award, McLain Ward said, "We owe our horses our lives and they ask only for kindness in return. We need to ensure their relevance does not fade away. This is our greatest responsibility as equestrians."

We are proud of the role we play in ensuring that horses are safe, healthy, and treated with dignity as partners. More and more equestrians now recognize that for the equestrian sport to progress and for the sport to have the acceptance of the public, the welfare of the horse must come first.

We deeply appreciate the generosity of the individuals and organizations that support the EQUUS Foundation. It is only through engaging passionate supporters and collaboration that we are able to accomplish our mission.


Horse Whisperers


